#### I. NAME

The name of the corporation is THOROUGHBRED OWNERS OF CALIFORNIA

#### II. PURPOSE

This corporation is a non-profit mutual benefit corporation organized under the Non-Profit Mutual Benefit Corporation Law. The purpose of this corporation is to engage in any lawful act or activity for which a corporation may be organized under such law.

III. INITIAL AGENT FOR SERVICE OF PROCESS

The name of the Corporation's initial agent for service of process is CT CORPORATION SYSTEM.

#### IV. BYLAW PROVISIONS

- (a) Directors. The manner in which Directors shall be chosen and removed from office, their qualifications, powers, duties, compensation, and tenure of office, the manner of filling vacancies on the Board, and the manner of calling and holding meetings of Directors, shall be as stated in the Bylaws.
- (b) Members. The authorized number, if any, and qualifications of members of the corporation, the filling of

vacancies, the different classes of membership, if any, the property, voting, and other rights and privileges of members, and their liability to dues and assessments and the method of collection, and the termination and transfer of membership shall be as stated in the Bylaws.

## V. LIMITATION ON CORPORATE ACTIVITIES

No substantial part of the activities of this corporation shall consist of the carrying on of propaganda, or otherwise attempting to influence legislation, nor shall this corporation participate or intervene in any political campaign (including publishing or distribution of statements) on behalf of or in opposition to any candidate for public office.
