PRESIDENT'S MESSAGE

The much-anticipated launch of Golden State Racing (GSR) kicks off on Saturday, October 19, at Pleasanton, marking a new era for Northern California racing. Just two weeks later, the Breeders' Cup World Championships will be held at

Del Mar, running on November 1 and 2.

GSR steps in to fill the void left by Golden Gate Fields, which closed in June. The closure left a gap of 120 race days, spanning from late August through early June, with a brief break in October to make room for the Big Fresno Fair and a second break in December. The rest of the year-round calendar is traditionally covered by CARF and Sonoma.

Northern California created a new blueprint, one that CARF and TOC designed through agreed-upon benchmarks in May. These benchmarks, part of the Race Meet Agreement submitted to the California Horse Racing Board (CHRB), lay out the roadmap for the region's racing future. Specifically, the North receives its chance to succeed, and the benchmarks spell out the metrics that define success.

The benchmarks established by TOC and CARF are based on strategic, objective metrics that set minimum standards for sustaining a viable two-circuit system in California.

President's Message, Cont.

This collaboration prioritizes the long-term health of California racing while establishing clear expectations for GSR's race dates from October 19 to December 15, 2024, and any new dates applied for in 2025.

Key benchmarks include:

- At least 3 race days per week
- A minimum of 24 Thoroughbred races per week
- Average daily purses of not less than \$170,000

GSR's official license application, submitted to the CHRB in September, largely adhered to these agreed benchmarks. The application matched the number of race days and the minimum race requirements per week, while ambitiously aiming for 26 weekly races—8 on Fridays and 9 on both Saturdays and Sundays. The only minor variance was in the total purse amount, with GSR proposing \$4.24 million (\$163,247 per day) in its submission—slightly below the benchmark target.

Why the Benchmarks Matter

Southern California racing has subsidized Northern California racing for years, about \$5 million annually based on recent data with the likelihood that it will trend higher in future years. In 2018, purses in Kentucky and Southern California were comparable. Today, a Kentucky-bred maiden runs for nearly double the purse of a comparable race in Southern California. The economic landscape has shifted dramatically, and California racing faces unprecedented challenges in maintaining competitiveness. Financial support between regions is no longer sustainable and each circuit must now be accountable for its own success.

Owners and breeders are aligned that a minimum standard of three race days and 24 races per week are a floor that must be met for a full-time racing circuit to continue in the North and the South. Minimum purse

levels are also needed in both the North and the South to help uphold a quality of racing that preserves and protects the image and acceptance of California racing, not only here at home but across the nation. Applying our limited resources to the most efficient use has never been more important than now.

Getting this right from the outset and maintaining the minimum standards is critical. The future of both circuits—and thousands of jobs—hangs in the balance. The overarching priority must be the overall health and quality of California racing that remains consistent with the brand and tradition established over several decades. The GSR benchmarks were set below Golden Gate's historical levels but slightly above traditional CARF standards, a reasonable middle ground to again help launch the new entity and give it every chance for success. Now it's up to GSR, which has pledged new investments and a fresh marketing approach, to improve results. In the end, competitive racing with attractive field sizes and three race days per week that meet the minimum standards will determine the overall handle and purse generation from California and interstate wagering sites, and that will ultimately decide the future viability of racing in Northern California.

Fenton became a TOC Board member in 2016 and has served as the organization's Chairman for the last three years.

California Crown Day - A New Racing & Entertainment Experience

The first-ever California Crown Day on September 28 provided something new with something old to create a top-class racing and entertainment experience, combining the great tradition of California horse racing with a modern-day twist to appeal to a new audience.

Some of the star names were new to many veteran racing fans, an impressive list that featured (Best New Artist) Shaboozey, Frank Walker, Lil Yachty, Gryffin, Zack Bia, and Funke as music and food were a big part of the festivities. For the real stars of the show, 1/ST Racing funded over \$3 million in purse money with major increases in the day's three featured races.

Cabo Spirit, a supplementary entry, won the \$750,000, Grade 2 California Crown John Henry Turf Championship, First Peace won the \$750,000, Grade 2 California Crown Eddie D Stakes, and Subsanador won the \$1 million, Grade 1 California Crown. These three races alone benefited from a combined purse increase of \$1.8 million and help set the stage for the Breeders' Cup World Championships at Del Mar on November 1-2.

The new audience was not limited to those who were part of the 21,812 in attendance at Santa Anita, but also the many who woke up early in Hong Kong for the morning simulcasts of the last four races of the California Crown race day. Total wagering, including Hong Kong, was over \$22 million.

Martin W. Bach
1940 - 2024

Martin W. (“Marty”) Bach, a prominent Northern California owner/breeder and former director of TOC, passed away on August 31. Bach served on the TOC board from 2003 to 2011 and remained an active member of the Northern California Racing Affairs Committee until the end, participating in a committee meeting just three weeks before his passing. He also chaired the Finance Committee for six years and was Treasurer of the organization from 2006-2010.

His many successful runners included Marty’s Zee, a homebred stakes winner of the Fairfield Stakes, multiple stakes winners City by the Bay and Look Quickly, and home-bred My Friend George. In partnership with Jack Owens, he campaigned the City Zip filly English Royal to 11 wins and multiple stakes placings. He also bred El Tigre Terrible, the 2019 Cal-bred champion two-year-old male.

Bach endeared himself to fellow board members and TOC staff alike with his cheerfulness, caring, and kindness. He was always approachable, with a ready smile and genuine interest in others’ opinions and wellbeing. He truly loved horse racing and always had the best interests of the industry and TOC at heart.

“His contribution to the TOC and to Thoroughbred racing was a result of the love and passion he brought to our sport,” said TOC President and CEO Bill Nader. “His knowledge, calm demeanor, and smile were always present, and we loved him. He will be remembered, and he will be missed.”

Wayne Atwell, TOC Northern California Director of Operations, who worked closely with Bach for years, said, “Marty was very passionate about horse racing in the North and very supportive of not only the horses, but the horsemen involved down to the grooms and hotwalkers. He maintained a broodmare band for decades in the North and bred to the top stallions in California. When Smiling Tiger passed away in mid-August, Marty reached out to the stallion manager to give his condolences. It was just two weeks before Marty passed away. Incredible.”

Richard Scheidt, former Northern California Director of Operations who worked closely with Bach for years, said, “Working with Marty Bach was a privilege I will always cherish. He was not only a steadfast advocate for the horsemen but also a tremendous support to me. He made a point to include me in memorable moments, often inviting me to the winners’ circle, where I now have many treasured photos of his winners.” Scheidt continued, “One of my fondest memories of Marty was his love for Trader Vic’s in Emeryville, a place he frequented with great enthusiasm. He was humble, always insisting I call him “Marty” instead of “Mr. Bach,” even though his presence commanded respect. What stands out most, though, was his genuine interest in my life—his kindness and personal connection are things I’ll never forget.”

A graduate of the University of Wisconsin-Madison, Bach was a senior vice president with Morgan Stanley and a financial advisor for 49 years. He is survived by Bobbi, his wife of more than 50 years, his son David and daughter Emily.

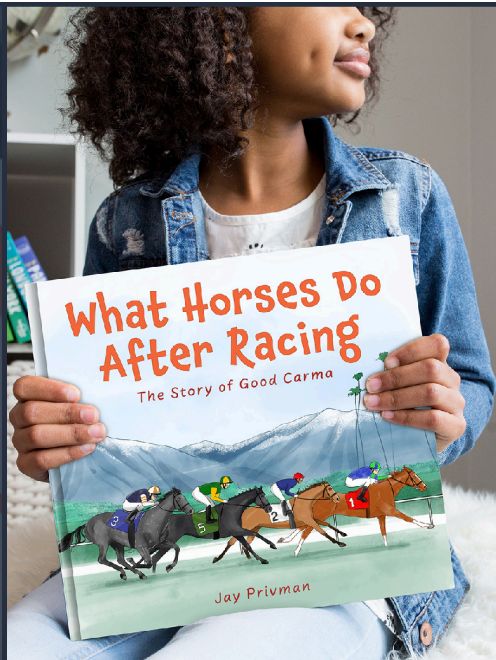

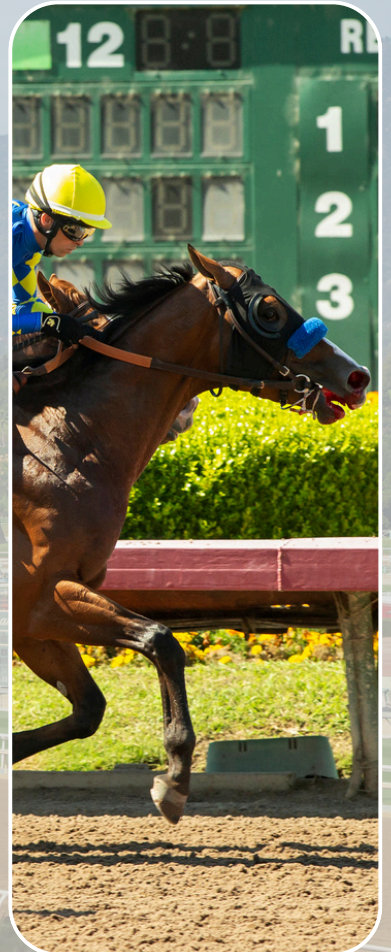
